PMUA & SCHOOL DISTRICT ROLL OUT IN-SCHOOL RECYCLE PROGRAM

In November the PMUA and the Plainfield Board of Education combined efforts by going into the schools to educate its administrators, staff and students on the districts new recycling program.

Presentations were made at Maxon Middle School, Washington Elementary, as well as at the Plainfield School District Administrative Building where the PMUA spoke about recycling and the goal of the newly implemented program. Introducing the blue containers, re-identifying where and how bottles, cans and paper should now be disposed, sharing the responsibility of separating recyclables at school, in addition to at-home recycling efforts, were some of the topics covered by the PMUA staff.

Working together in kicking off phase I of the Plainfield School System Recycling Initiative, the PMUA hopes to increase the amount of recyclables generated from each

building in the school district. This increase allows us to rescue recyclables from the general waste stream, which helps to contain costs because the tonnage of regular trash collected decreases. Separating recyclables from the trash = less trash. This decrease is a key factor towards stabilizing costs.

The PMUA will continue to work with the Board of Education while rolling out Phase II of the Recycle Program into the remaining facilities in early 2008.



PMUA team members paid a visit to Washington Elementary School students and staff on November 28th, to celebrate the kick-off of Phase 1 of a new in-school recycling initiative. The joint effort of both the Board of Education [project headed by Harold Gee, Asst. Supervisor of Buildings and Grounds] and the PMUA, this venture shows great promise in successfully capturing the large volume of recyclable paper (and co-mingled) items generated in the class-rooms, admin. offices, faculty lounges and student cafeterias throughout the school(s).

HAROLD W. GEE, SR.

PLAINFIELD BOARD OF EDUCATION ASSISTANT SUPERVISOR OF BUILDINGS & GROUNDS



Mr. Harold W. Gee, Sr. is the Assistant Supervisor of Buildings & Grounds for the Plainfield Public School District. He and his department are responsible for the managing and maintenance of all school buildings and grounds. Currently in his 5th year with the Plainfield Board of Education, Mr. Gee came to the District from Lucent Technologies where he was their Supervisor of Buildings and Grounds and the company Certified Recycling Coordinator. Mr. Gee received his New Jersey Recycling Coordinator's Certificate from Rutgers University.

What challenges does your department face while servicing the school district?

One challenge is keeping up with the overall maintenance of the buildings because we have several facilities in the district which house so many students. This in combination with the population, plus the fact that our buildings get used in the evenings by a number of organizations, equals a lot of wear and tear on our infrastructure. We do our job and make sure that everything runs efficiently in all the buildings and that we stay on top of things. Are there any new initiatives that your department is currently working on?

One of our main initiatives at the moment is implementing a more comprehensive recycling program throughout the school district. Introducing this in two phases, we have recently kicked off phase I. All of the administrators and staff will be getting blue containers in all offices and one at every desk. By designating separate blue containers for recycling only, we are re-educating our staff on proper recycling practices and protocol. Our focus is on the recycling of white paper, color paper and co-mingled items. This initiative will work in conjunction with the cardboard and newspaper recycling program that is already in place. We will continue to train and educate on recycling with the goal in mind of increasing the amount and types of recyclables generated from our buildings. In 2008, we will roll out Phase II where we hope to have a blue container in every classroom throughout the district.

How has the PMUA been involved with the districts new recycling initiative?


Our recycle program is a joint effort between our department and the PMUA. From the ground level, the PMUA joined us and helped brainstorm ideas and brought in representation from Union County to discuss recycling initiatives for the school district. Working together, we came up with a plan

which addressed the needs of the district while at the same time working with the PMUA to increase recycling in the schools.

What is your #I priority for 2008?

To work on the landscaping around our buildings. We will be focusing on making the outside of the buildings more green by cleaning them up, eliminating weeds, and establishing lawns. We are also preparing the ball fields for the spring by fertilizing and aerification/ cultivation. In addition, we are making sure that our custodians are properly trained to follow certain procedures that are already in place to keep the facilities as clean as possible. Keeping the buildings clean is a top priority. We will continue to work diligently on sanitizing.

REV. DONALD NICHOLS PASTOR OF THE MT. OLIVE BAPTIST CHURCH

Rev. Donald Nichols, Pastor of The Mt. Olive Baptist Church has been pastor of the church for 30 years and a member of the congregation since he was a young boy. A life-long Plainfield resident and graduate of Plainfield High, Pastor Nichols will share some thoughts on life, his congregation and the Queen City with PMUA News.

Being a Pastor, I do a little bit of everything. I deal with people and help them through difficulties by counseling and mediating. My time is spent doing weddings, funerals, baby dedications and preaching during services. It is a very rewarding experience. For 30 years I have been around to see the changes and watch the children grow up.

Describe the ministries at The Mt. Olive Baptist Church and the charitable work you are involved with?

Our church is greatly involved in the community. We feed the homeless, hold clothing drives, have a Christmas Tree Wish List, and hosted a Thanksgiving dinner for anybody who wanted to come. Mt. Olive also created the Liberty Community Development Corporation which is a non-profit group who started the "PRNT Shop", (People Reorganizing Neighborhood Ties) where we hire people who have recently been released from prison to learn the printing trade and work at the shop. Our "Another Chance" group is made up of youngsters ages 19-35, these young adults have been out in the world and volunteer to help the community by lending a hand to better the City. By giving them an outlet, they are working to alleviate some of the problems faced by young people and take a more proactive stance.

We are proud of The Mt. Olive Scholarship Ministry which awards 4 scholarships annually to help children pay for college. Besides the scholarships, we give stipends to all church members who are in college to help pay for books. Any church member in college is awarded book money. Our scholarship committee is in the process of creating an alumni association to help with fund raising efforts. Mt. Olive also honors all high school graduates by having them speak at services in June.

What future changes would you like to see take place in our City?

I would like to see a change in people's attitude and a spiritual change. Respect for one another is something I preach and teach, to love one another and have concern for another human being. I would like to see more of that in Plainfield again, as there once was years back. I still have hope for the City. We seem to be making progress in many areas. So much is happening such as the new Senior Center and



building and improving the infrastructure. But every organization in the City should be working to influence the welfare of the people.

Can you give some words of wisdom to the youth of Plainfield?

Respect one another and use the Bible golden rule... "Do onto others as you would have them do onto you". Learn what is right and wrong and avoid anything detrimental to human life. Try to overcome any obstacles.

Being a Plainfield resident for many years, how has the presence of the PMUA affected the community?

The system of garbage collection implemented by the PMUA has had an impact because it is a much cleaner operation. Regular pick-ups that are on-time have been a great innovation for the City.

AVOID FINES - PLEASE FOLLOW THE CURBSIDE COLLECTION GUIDELINES BELOW:


- LIDS MUST BE COMPLETELY CLOSED on all trash containers rolled out for curbside collection .
- Do not leave trash on top of the lid or on the side of container. (Extra trash can be taken to the PERC/ Transfer Station, or saved for your next pick-up date)
- Make sure your cart is put away by 8:00 p.m. the day of pick-up.
- Regular garbage goes in the BLACK cart only. Co-mingled recyclables in BLUE carts only.
- Construction debris or vegetative waste (leaves, etc) should not be disposed of in your black cart.

NO RECYCLING COLLECTION on the 5th Wednesday of any month - No collection January 30, 2008 RECYCLE RULES REMINDER - Plastic bags SHOULD NOT be discarded with recyclables:

Co-miniged items should be discarded loosely in your blue recycle container. Do Not use plastic bags to hold co-mingled items inside your recycle container OR Please remove any plastic/garbage bags from your blue recycle cart prior to roll-out for collection.

PMUA & DPW Join Forces To Clean-Up Downtown








